Poolside Passes

Cost per pass per day = £15*

Clubs must adhere to Swim England's supervision ratio policy, more information can be found at https://www.swimming.org/swimengland/swim-england-relases-supervision-ratios-policy/

All coaches, chaperones and team staff must be in possession of a poolside pass to access the event. This must be worn at all times in the venue. It is mandatory that anyone applying for a poolside pass must have a valid and in date DBS, safeguarding training in line with Wavepower (2024) and appropriate qualifications. Chaperones for para swimmers are to be on a 1:1 basis.

*In order to help clubs with the rising costs associated with a ending galas, and the increasing number of coaches and team managers required on poolside by Swim England's supervision ra os policy, all clubs will receive one free poolside pass for the weekend. Clubs bringing five or more coaches or team managers will receive two free poolside passes.

Draft Programme

Sports Information Desk

Coaches passes, withdrawal forms, a copy of the programme as-well as volunteers assigned to assist coaches and competitors with information or queries can be found at the Sports Information Desk, accessible by the dry-side of the building, near the café.

Warm Up and Swim Down

The competition pool will be available for warm-up ahead of each session. The dive pit will be available throughout the competition from the start of the first warm-up each day.

Call Room

The swimmers must report to the Call Room, which can be located at the base of the diving towers at the side of the dive pit.

Spectator Passes will be available for purchase from the front desk on the day of the event for £10 per day.
